TIMELY INFORMATION FROM THE BOARD AND SUPERINTENDENT Dr. Bell shared, "In preparation of the start of school, Mr. John Binchi, Director of Maintenance and Operations took Ms. Andrea Reynolds and I on a tour of the sites, to view the major construction projects. Thanks to Mr. Binchi, a multitude of projects were accomplished including an electrical upgrade at Macy Elementary School, a new ADA compliant bathroom at Meadow Green Elementary School, and window coverings at all our sites for safety purposes.

Last Monday, August 11, most staff returned to work and we held a welcome back pancake breakfast and districtwide convocation where I shared the message of "Orchestrating the Future." This was followed by staff development for Office Managers and all of our certificated staff members.

Enrollment projections for both school sites and districtwide are on target, if not modestly up. The multi-year budget projections assumed enrollment to be at 3,169 for this school year and we are at 3,174. Our class-size averages for grades TK – 3 range from 24.1 to 25.3 and upper grades class size averages range from 32.1 to 34.0. Rancho-Starbuck has exceeded the 800 mark! They currently have 801 students enrolled.

I was able to get to every school site on three separate occasions last week to touch basis with the office staff and principals, and today I visited upper grade classes at Meadow Green and sat in on collaboration meetings at El Portal and Macy.

With the beginning of school comes our annual parent information meetings. I will have the opportunity to attend our Back-to-School night events over the next few weeks. Macy Elementary School
